Explanation of Responses:

1. Represents the conversion into common stock of vested restricted stock units ("RSUs").
2. Each RSU represents a contingent right to receive one share of the Issuer's common stock.
3. As previously reported on Table II of a Form 4 filed in connection therewith, on May 10, 2016, the Reporting Person was granted 2,520 RSUs, which, together with additional RSUs awarded to the Reporting Person on account of dividend equivalent rights associated with such RSUs, vested on the first anniversary of the grant date. The Reporting Person elected to defer delivery of the common stock into which such RSUs vested until May 10, 2019. The common stock into which such vested RSUs converted is reported on Table I of this Form 4.
